

# RECERTIFICATION FORM

SCTE certification is valid for three years. You have the opportunity to apply for recertification during the six months prior to the expiration date printed on your certification certificate or 12 months afterward. A total of 12 recertification units (RUs) (21 RUs for DVEP and IPEP) are required to maintain your certification without having to retake the certification exam. If you have not earned the minimum RUs, you may retake the exam, incurring the cost of the testing fee and the renewal application fee.

Failure to apply for recertification within the above-mentioned timeframe will result in a lapse of your current status. SCTE attempts to send recertification reminders to its certified candidates as a courtesy. The candidates retain responsibility for ensuring all recertification requirements are fulfilled prior to certification expiration whether the candidate receives a recertification reminder from SCTE.
